



Untying Knots Counseling, PLLC Notice of Privacy Practices updated January 1st, 2026

THIS NOTICE DESCRIBES HOW MEDICAL INFORMATION ABOUT YOU MAY BE USED AND DISCLOSED AND HOW YOU CAN GET ACCESS TO THIS INFORMATION. PLEASE REVIEW IT CAREFULLY.

By law, and in accordance with the ethics of the counseling profession, Untying Knots Counseling, PLLC and their providers are required to protect the privacy of your personal health information (PHI) as mandated by the Health Insurance Portability and Accountability Act (HIPAA). This practice is also required to give you this notice to explain how PHI may be used and disclosed, as well as to inform you of your rights pertaining to your PHI.

PHI includes any information about you, and records of services you received through this practice, including and not limited to:

- Dates, times, and lengths of your therapy sessions
- Information you disclosed during sessions, over the phone, in email, or at other times
- Your therapist's observations of you
- Your therapist's assessment of your mental health concerns
- Results of psychological tests and diagnostic interviews
- Treatment plans
- Medication Records
- Billing and insurance information
- Records obtained from other healthcare providers who have treated you

How We May Use and Disclose your PHI

State and federal laws allow Untying Knots Counseling, PLLC and their providers to use and disclose your PHI to provide services. Providing treatment services, collecting payment and conducting healthcare operations are necessary activities for quality care.

Treatment

Your PHI can be used and disclosed to manage and coordinate your care. This could include consultation to improve your care, coordination with another provider who is treating you, and for referral purposes.

Payment

Your PHI can be used and disclosed to bill for services and receive payment from health plans and other entities. Your health insurance plan may use this information to make determination of coverage for benefits, review services to determine medical necessity, and for utilization review activities. If your account is referred to a collection agency, the collection agency may ask for parts of your PHI relevant to their task.

Healthcare Operations

Your PHI can be used and disclosed to run this practice, improve your care, contact you when necessary, and resolve any complaints you may have. Your information may also be used to review treatment procedures, review business activities, certification, training, compliance and licensing activities.

Other Uses and Disclosures of your PHI

The providers at Untying Knots Counseling, PLLCs are allowed or required to disclose your PHI in other ways – usually in ways that contribute to the public good, such as public health and research. This practice has to meet conditions in the law before your information can be disclosed for these purposes, and disclosures will be made in a manner consistent with applicable laws. Help with Public Health and Safety Issues

We can disclose PHI about you for certain situations such as:

- Preventing disease and the spread of communicable illnesses
- Mandated reporting of suspected abuse, or neglect
- Preventing or reducing a serious threat to anyone’s health or safety including emergency situations

Conduct Research

We can use or disclose your PHI for health research. Untying Knots Counseling, PLLC does not currently conduct research, but would inform you if anything changes.

Comply with the Law

We will disclose PHI about you if state or federal laws require it, including with the Department of Health and Human Services if it wants to see that we are complying with federal privacy law, or to state licensing board for investigations of complaints.

Address workers’ compensation, law enforcement, and other government requests

We can use or disclose PHI about you:

- For workers’ compensation claims
- For law enforcement purposes or with a law enforcement official
- With health oversight agencies for activities authorized by law
- For special government functions such as military, national security, and presidential protective services

Respond to lawsuits and legal actions

We can disclose PHI about you in response to a court or administrative order, or in response to a subpoena.

Law Enforcement

We can disclose limited information to assist law enforcement purposes, such as locating a missing person, or in the event that a crime occurs on the premises of this practice.

Your Choices

For certain PHI, you can tell us your choices about what we disclose. If you have a clear preference for how this practice discloses your information in the situations described below, please inform your provider at Untying Knots Counseling, PLLC of your request *in writing*. Reasonable efforts will be made to follow your instructions.

-In these cases, you have both the right and choice to tell us to:

- Disclose PHI with your family, close friends, or others involved in your care
- Disclose PHI in a disaster relief situation

If you are not able to tell us your preference, for example if you are unconscious, we may go ahead and disclose your information if we believe it is in your best interest. We may also disclose your information when needed to lessen a serious and imminent threat to health or safety.

-In these cases we never disclose your PHI unless you give us written permission:

- Marketing purposes-the Providers at Untying Knots Counseling, PLLC will **NEVER** use your PHI for marketing purposes.
- Sharing of psychotherapy notes (these are notes separate from your formal electronic records).

Your Rights

When it comes to your PHI, you have certain rights. This section explains your rights and some of our responsibilities to help you. Get an electronic or paper copy of your medical record (electronic information sent through secure and encrypted means).

- You can ask to see or get an electronic (when possible) or paper copy of your medical record and other PHI we have about you. This request must be made *in writing*.
- We will provide a copy or a summary of your PHI, usually within 15 business days of your request. We may charge a reasonable, cost-based fee (outlined in the informed consent).

Ask us to correct your medical record

- You can ask us to correct PHI about you that you think is incorrect or incomplete. This request must be made *in writing*.
- We may say “no” to your request, but we’ll tell you why in writing within 15 business days. If your request is denied you have the right to file a disagreement in writing which will be kept in your record.

Request Confidential Communications

- You can ask us to contact you for appointment reminders, issues regarding payment, and treatment issues in a specific way (for example, home or office phone) or to send mail to a different address.
- We will say “yes” to all reasonable requests.

Ask us to Limit what we Use and Disclose

- You can ask us not to use or disclose certain PHI for treatment, payment, or our operations. We are not required to agree to your request, and we may say “no” if it would affect your care. This request must be in writing and specify what restrictions are needed.
- If you pay for a service out-of-pocket in full, you can ask us not to disclose that information for the purpose of payment or our operations with your health insurer. We will say “yes” unless a law requires us to disclose that information.

Get a List of Those with whom we have Disclosed Information

- You can ask for a list (accounting) of the times we’ve disclosed your PHI for six years prior to the date you ask, who we disclosed it with, and why.
- We will include all the disclosures except for those about treatment, payment, and health care operations, and certain other disclosures (such as any you asked us to make). We will provide one accounting a year for free but will charge a reasonable, cost-based fee if you ask for another one within 12 months.

Get a Copy of this Privacy Notice

You can ask for a paper copy of this notice at any time, even if you have agreed to receive the notice electronically. We will provide you with a paper copy promptly. We will also share the signed copy of this notice with you via your Therapyportal.com account.

Choose someone to act for you

- If you have given someone medical power of attorney or if someone is your legal guardian, that person can exercise your rights and make choices about your PHI.
- We will make sure the person has this authority and can act for you before we take any action.

File a complaint if you feel your rights are violated

- You can file a complaint with the Texas Behavioral Health Executive Council (BHEC) by calling 1.800.821.3205 or sending a letter to:

- We will not retaliate against you for filing a complaint.

Our Responsibilities

- We are required by law to maintain the privacy and security of your protected PHI.
- We will let you know promptly if a breach occurs that may have compromised the privacy or security of your information.
- We must follow the duties and privacy practices described in this notice and give you a copy of it.
- We will not use or disclose your information other than as described here unless you tell us we can in writing. If you tell us we can, you may change your mind at any time.

Let us know in writing if you change your mind.
